Description

1. The Tarlac State University, through Special Budget (SB) 2025 intends to apply the sum of Forty-Nine Million Four Hundred Seventy-Three Thousand One Hundred Seventy-Five and 79/100 Pesos (₱ 49,473,175.79) to payments under the contract for the project: Construction of Academic Building 2 (Phase I). Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Tarlac State University now invites bids for the aforementioned Project. Completion of the Works is required within Three Hundred Thirty (330) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non- discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Three (3) copies of the bid proposals (one original, and additional copy 1 and 2) must be submitted to the BAC which must be duly received by the BAC Secretariat through manual submission at the office address indicated in the bidding documents, on March 17, 2026 at 9:30 A.M. Failure of bidders to comply with the said request of additional copies shall not be a ground for disqualification.

Late submission shall not be accepted.
